2.0 USES

Staron® lavatories and sinks are used as plumbing fixtures.

3.0 DESCRIPTION

Staron[®] lavatories and sinks are solid-surface, one-piece designs of 100 percent acrylic. Overflows are external. The following models are covered by this report: lavatories A3181, A3201 and A3211; and kitchen, bar, laundry and service sinks A1181, A2311, A2321, A2341, A1121, A1131 and A1231.
